## Application Checklist for Individual Artists:

- Application (filled out and signed)
- \$20 check for Application Fee (non-refundable).
- \$25 for a Tybee Island Vendor permit, if you do not have a Tybee Business License to be included in the Booth fee check.
- \$150 check for Booth fee if you are requesting a 10'x10' space in the big tent (artist may provide own tent frame [no tops] if needed).
- \$175 check for Booth fee if you are requesting a 10'x10' individual tent outside the big tent (only provided high peak tents will be allowed).
- SASE if you wish for your application material to be returned.
- CD of numbered jpg images or numbered 4x6 photos labeled with your name, phone number. Numbers should correspond to your list of enclosed images.
- Numbered list of enclosed images.
- Cover Letter describing what sets your work apart.

## Additional items to include for all GALLERY applications:

- One Application fee per artist you wish to display, only juried artists will be allowed to display items in your booth.
- 3 Images per artist. Please put all artist images on 1 CD and number them. Numbers should correspond to your list of enclosed images.
- 1 Numbered list of enclosed images including name of artist, title of work, medium used and price.
- Name and Tybee address for your business. Only Art Galleries on Tybee Island will be considered for admission to the festival.

It will be the hub of island activity on festival weekend and will include artists from throughout the Southeast. Entries will be juried for cash awards on Saturday morning. No charge to the public. Thousands of visitors come to this festival each year!

# TYBEE FESTIVAL OF THE ARTS 2010

**Entrance Requirements:** All applications will be juried. The jurist's decision is final. All art on display must be the work of the applicant. In the case of galleries, each artist you are representing should be submitted for the juror to consider (see the checklist for details).

Applications must be accompanied by a 1 page cover letter, 3 jpg images (please include at least one image of every type of work you plan to display), and 1 jpg image of your display booth all preferably on CD. If necessary, good quality, clear photos, at least 4x6 in size, will be accepted. **No slides** will be reviewed. If applicable, please include your website address.

No kits, items created from patterns, works created from commercial molds, or work copied from another source will be allowed. Reproductions of artist's work must be labeled as such. Work created from purchased materials should exhibit a substantial creative input by the artist. Digital images must be produced from input/photos created by the artist.

Jewelry and photography are popular categories. Be sure to give us a description of what sets you apart. The festival committee will review all submissions for compliance with these requirements.

A non-refundable \$20 application fee (per submitted Artist) and a \$150 booth fee plus a \$25 Vendor Permit fee (if you do not currently have a Tybee Business License) must be included in your application packet. **Please write two (2) separate checks.** The booth fee and Vendor Permit fee will be returned if your work is not accepted.

**We retain the right to remove work which was not accurately represented.** Acceptance in any festival does not ensure acceptance in future years.

**Booth Space:** Artists will be assigned a space in our big, beautiful, 150 foot tent or in individual 10 by 10 stand alone tents. One artist, arts organization, or gallery [from here on collectively referred to as artist(s)] are allowed per booth. Nighttime security is provided. Artists must provide their own display setup. Be prepared for wind as the site is on the beach. Artists are responsible for collection and payment of Georgia sales tax (7%). Artist demonstrations are encouraged.

## ELIGIBILITY and REQUIREMENTS

- ◆ Open to all creators of fine art and fine craft.
- ◆ Judges will consider each exhibitor's body of work for award consideration. Works must have been completed within the past three years.
- ◆ Work must be professionally displayed in your booth for judging by 9 a.m. Saturday, October 16th.
- ◆ Sculpture and floor pieces must fit within your 10' by 10' booth space unless approved by show staff.
- ◆ Please provide a minimum of three (3) .jpg (preferred) or photographs that justly represent your work for jury deliberations. Please also include one (1) image of your booth and display as well. Be sure to provide clear and sharp images as these will be used in the jury process for show acceptance

Notifications of acceptance will be mailed to artists by August 15, 2010. Write two checks payable to Tybee Arts Association Inc., one for the booth fee and Vendor Permit fee (when applicable), the other for the jury fee. The booth fee/Vendor Permit check will be returned if you are not accepted. The \$20.00 jury fee is non-refundable. No refunds after August 22<sup>nd</sup>.
