### EXHIBITION SCHEDULE

**Submission deadline: Friday, Oct. 28, 2011 (Entry form below must be postmarked by this date; none will be accepted after this date; please watch for future shows for participation.)**

**Delivery of artwork: Wednesday, November 2, between 3pm and 7pm at the Cafeteria (Please bring 2 copies of completed form for receipt of work.).**

**Exhibit dates: November 4 from 6-9 pm and November 5 from 10 am to 6 pm and November 6 from 10 am to 5 pm**

**Artwork pick up: Sunday, November 6, 5:00pm – 5:30pm only.**

### ELIGIBILITY

The show is open to all members of the Tybee Arts Association whose membership is current at the time of exhibition. Go to: <http://tybeearts.org/contact/join-support/> for membership information. All participants must commit to work at least 5 hours before the show and 3 hours during the show. Please provide a resume/statement and business cards if available. New artwork is requested for each show. Artwork which has been shown 4 times at prior shows should be excluded.

### LIMITATIONS

All media are eligible. Artists, however are responsible for providing any installation instructions and special equipment, including any electronic equipment the work might require. Work must be ready for display. Final display decisions are at the discretion of the monthly chair.

### ENTRY FEES

A nonrefundable fee of \$10 must be paid to the Tybee Arts Association (see Submission of Payment and Entry).

### EXHIBIT SPACE

Space will be determined by the number of participants entered on the deadline. Applicants will be contacted by email no later than the Monday prior to the show.

### SALES

All works must be labeled and priced using the Tybee Arts Association labels provided (available during art drop-off). A 20% commission will be charged on sales.
